# Tent/Canopy, Temporary Event, or Staging **Permit Application Checklist**

All of the following information is required and must be submitted. Checking off each item as you prepare your application package will ensure your package is complete and will help to expedite the permitting process.

### One (1) complete application packet must include, in addition to the completed application:

	A plot plan or site plan of the property showing complete locations of tents, staging locations, exits and entrances, parking and existing building locations (including dimensions for all). If using temporary staging, you will need to include product information and structure details. (Applicant may call Parks & Recreation for maps of Portland's Parks @ 756-8275).
$\square$	If the City is the property owner, a Certificate of Insurance listing the City as additional insured is required. Minimum amount of coverage is \$400,000.00
$\square$	Electronic files in PDF format are also required (separate PDFs, per document, and named appropriately)
$\square$	Certificate of Flammability
	Written notice of approval of owners (If the City is owner, attach a completed copy of Application to Use City Parks & Public Space from Parks & Recreation, 756-8275.)
X	Company name of installer (complete contact info)

Please submit all of the information outlined in this application checklist. If the application is incomplete, the application will be refused.

In order to be sure the City fully understands the full scope of the project, the Planning and Development Department may request additional information prior to the issuance of a permit. Permit Fee: \$30.00 for the first \$1000.00 construction cost, \$10.00 per additional \$1000.00 cost

#### Electronic Signature and Fee Payment Confirmation

Within 24-48 hours, upon receipt of an e-mailed invoice from Building Inspections, which signifies that my electronic permit application and corresponding paperwork have been

received, determined complete, entered by an administrative representative, and assigned a permit number. I then have the following four (4) payment options: provide an on-line electronic check or credit/debit card (we now accept American Express, Discover, VISA, and MasterCard) payment (along with applicable fees beginning July 1, 2014), call the Inspections Office at (207) 874-8703 and speak to an administrative representative to provide a credit/debit card payment over the phone, hand-deliver a payment method to the Inspections Office, Room 315, Portland City Hall, deliver a payment method through the U.S. Postal Service, at the following address: City of Portland, Inspections Division 389 Congress Street, Room 315 Portland, Maine 04101 Once my payment has been received, this then starts the review process of my permit. After all approvals have been met and completed, I will then be issued my permit via e-mail. No work shall be started until I have received my permit.
