

Here is a list of most of the major material to be used:

- New wall framing 2x4 kd spruce (All the existing outside walls of the unit are 2x4 spruce)
- Drywall 1/2" thick (Again, the existing interior walls are plaster, but all the outside walls are 1/2" drywall)
- New kitchen cabinets TBD (could be wood, could be laminated particle board as existing)
- New interior doors 6 panel wood
- New flooring Pergo type laminated snap together flooring
- Trim Painted wood trim (style to be determined).
- Bathroom tub enclosure tile
