Appointments must be requested 48 to 72 hours in advance. The inspection date will need to be confirmed by this office.

- **Permits expire in 6 months if the project is not started or ceases for 6 months.**
- **If the inspection requirements below are not followed, then additional fees may be incurred due to the issuance of a "Stop Work Order" and subsequent release to continue.**
- **Per Section 107.3.1 of the Maine Uniform Building and Energy Code (MUBEC), one set of printed approved stamped construction documents will be kept at the site of work and open to inspection by building officials.**

It shall be the owner's responsibility to contact the Code Enforcement Officer and provide them with evidence of that specific date.</p> <p>2) This permit is approving only the demolition of the existing structure.
