As promised, I'm forwarding a photo of the Scott Teas design done for a site on Sheridan Street a few years back, and that I sent to Ethan at Adams Apple LAST SPRING (see the date on my first e-mail below, it was MAY 7!!). We thought and still think this project could provide great design inspiration for 65 Munjoy, if you stripped the glass penthouse off the top and kept it at three stories.

Anyway, I followed-up this May 7 e-mail/photo to Ethan with a phone call, so I gave him all the context about the purpose of the photo, and our desire to engage them in a discussion of a design concept more in keeping with the RFP and Adams Re-use Committee recommendations. He even referenced the photo in a Sept e-mail in which he said to be patient, because no progress was being made on the design yet, and he'd be in touch as soon as they re-engaged with the architect. And of course, as you know, he never reached back out to us, despite our attempts to follow up. Next we knew, they'd finished their end-run around a real public process and were already at the planning board. Wow!

This whole experience -- 10 years of leading and participating in a City-sponsored public visioning process, only to see the neighborhood's design recommendations ignored at the very end, including by the City! -- is not making us happy campers!

Pls add this e-mail chain and photo to the public record and materials for the Planning Board.
