PROJECT SUMMARY

EXISTING CONDITIONS:

THE LOT AT 40 O'BRION STREET IS CURRENTLY UNOCCUPIED WITH NO STRUCTURES CURRENTLY BUILT.

PROJECT DESCRIPTION:

THE 2 UNIT BUILDING WILL CONTAIN PARKING ON THE BASEMENT/GARAGE LEVEL (4 PARKING SPACES). THE TOP THREE FLOORS ARE SPILT DOWN THE CENTER INTO TWO SEPARATE 3-STOREY UNITS (2 UNITS TOTAL). THE UNITS ARE ACCESSED FROM ONE MAIN ENTRANCE ON THE GARAGE LEVEL WITH A STAIR THAT GOES TO THE 1ST FLOOR WITH A SEPARATE DOOR FOR EACH UNIT. THE ADDITIONAL FLOORS ARE ACCESSED WITH STAIRS WITHIN EACH UNIT.

MECHANICAL, ELECTRICAL AND PLUMBING:

NEW MECHANICAL, ELECTRICAL, AND PLUMBING SYSTEMS WILL BE INSTALLED IN THE NEW BUILDING. THE MEP SYSTEMS FOR THE BUILDING WILL BE DESIGN-BUILD. THE CONTRACTOR IS RESPONSIBLE FOR OBTAINING ALL PERMITS FOR THIS WORK.

SPRINKLER SYSTEM:

THE NEW BUILDING WILL BE FULLY SPRINKLED WITH AN NFPA 13-R SYSTEM. THE CONTRACTOR IS RESPONSIBLE FOR OBTAINING ALL PERMITS ASSOCIATED WITH THE SPRINKLER SYSTEM.




