Hello-

I spoke with Arthur Howe on the phone and he told me to complete the form and provide proof of the non-smoking clause in my lease with the current tenants. I also included a letter from the Portland Fire Department dated September 25th, 2015 evidencing that 33 Morning Street passed a fire safety inspection. Additionally, Mr. Howe told me not to send a check, but that the City of Portland would invoice me for the \$97.50 representing the registration fee for 3 units. This fee is the standard fee of \$35 per unit

totaling \$105 minus \$2.50 per unit for having a non-smoking building.
