## Tent Rental Contract Terms and Conditions

### RESERVATIONS

Quotes and proposals do not guarantee availability. Equipment will be reserved upon receipt of a signed rental contract and 50% deposit. Final balance is due in full upon installation.

First time customers must provide a valid credit card to place a reservation. If rental items are damaged, lost, or stolen during the rental period the customer will be charged a damage fee or replacement cost. Any fees will be charged to the credit card.

Customers may obtain the services of a Maine Bay Canvas employee during the event, additional charges will apply.

### CANCELLATIONS:

If the customer cancels the reservation at least 90 days prior the delivery date Maine Bay Canvas will refund the deposit in full less any expenses. If cancellation occurs within 90 days of the event, or if we had to refuse rental elsewhere, the deposit will be forfeited. If cancellation occurs within 7 days of event customer is responsible for full balance.

### WEATHER:

Customer understands that tents are temporary structures designed to provide limited protection from weather conditions. There may be situations that become unsafe such as high winds or lightning. Evacuation of tents is recommended in these or other unsafe conditions. **DO NOT USE TENT AS SHELTER DURING EXTREME WEATHER.** Should heavy weather or an "act of God" require an emergency service call, we will do our best to respond as quickly as possible. In this case the customer agrees to pay \$50.00 per man

### SITE PREPERATION INSTALLATION AND TAKEDOWN:

Please make sure your site is ready (i.e. lawns mowed and cleared of obstructions) prior to our arrival. Customer will inform Maine Bay Canvas of any underground utilities, (i.e. power lines, phone lines, gas lines, sprinkler systems, septic tanks, etc.) or any conditions that may interfere with the ability to stake or anchor tents. Customer assumes all responsibility for all damages in absence of such notice. Any permits are the responsibility of the customer.

Prior to the takedown any non-rental items including any decorations and trash will be removed from underneath the tent. Tables and chairs will be broken down and stacked. Any items that have been soiled will be cleaned. Any deviation from the above that causes Maine Bay Canvas additional time and/or expenses may be billed as an additional charge.

### INSTALLATION:

All items requiring installation will be installed by Maine Bay Canvas personal (sidewalls not included). Customer will not move or disassemble any items once they are installed. This includes removing any anchor points.

### DELIVERY:

Maine Bay Canvas will strive to accommodate the customer's delivery request. However, delays and changes to the schedule are sometimes unavoidable. Maine Bay Canvas will communicate any change in delivery as they occur. The customer must be available to count all items upon delivery and pick-up. If customer is unable to be there at time of delivery all item counts will be considered accurate.
