thence N 28°-17'-47" W along the land of said Rockingham LLC a distance of 17.79 feet to an 8" diameter wood post;

thence N 59°-36'-38" E along the land of said Rockingham LLC a distance of 7.81 feet to a capped iron rod found (PLS #2205);

thence N 57°-13'-32" E along the land of said Rockingham LLC a distance of 8.88 feet to a point;

thence N 57°-22'-28" E along the land of said Rockingham LLC a distance of 9.88 feet to a capped iron rod found (PLS #2205) and land of said Morgan Gavin LLC;

thence N 55°-28'59" E along the land of said Morgan Gavin LLC a distance of 64.46 feet to the point of beginning.

thence S 55°-29'-23" W across the land of Melinda Schott a distance of 25.00 feet to a point;

thence N 34°-30'-37" W across the land of Melinda Schott a distance of 15.00 feet to a point and remaining land of Glenn A. Morse;

thence N 55°-29'-23" E along the remaining land of Glenn A. Morse a distance of 25.00 feet to the point of beginning.

thence from said point of beginning S 55°-29'-23" W along the land of Melinda Schott a distance of 25.00 feet to a point;

thence N 34°-30'-37" W across the remaining land of Glenn A. Morse a distance of 15.00 feet to a point;
