Thank you for your patience. I got all the dimensions, exits, and other information for the permit. I have reattached everything in case you do not have it in addition to the new plot map. Here are some details on the map:

- -tent is 40'x60'
- -it is being set up in the Urban Farm Fermentory front lot
- -dimensions on the map include distance from street, distance from shrubbery, distance from building, distance from trees, and distance from nearest edge of lot.
- -there is no temporary staging
- -the tent is open on all sides, so there are not designated entrance/exit points.
