

The premises are conveyed together with and subject to any and all easements or appurtenances of record, insofar as the same are in force and applicable.



**EXHIBIT A**

A certain lot or parcel of land, with the buildings thereon, situated on the northwesterly side of Fox Street in the City of Portland, County of Cumberland and State of Maine, bounded and described as follows:

Beginning on the northwesterly sideline of Fox Street at the southeasterly corner of land now or formerly of Gertrude L. Curran; thence northeasterly by Fox Street fifty (50) feet to the southwesterly corner of land now or formerly of Ralph Tucci, et al; thence northerly by said Tucci land forty-five (45) feet, more or less, to the southerly sideline of land now or formerly of Carmine Ferrante, et al; thence westerly by said Ferrante land thirty-six (36) feet to the northeasterly corner of said Curran land; thence southerly by said Curran land sixty-three (63) feet to the point of beginning.
