I have just spoken with Charles Wordell in DPS who will be following up re the E 911 mapping and he also advises all the emergency responders of the final numbering once it is constructed. He and Chris will be looking into this in detail, but I just wanted to let you know that what you have suggested in the sketch is somewhat "unconventional" from his viewpoint and is not in line with similar developments.

So- I expect that he and Chris will come up with a draft numbering map based on precedent and "rules"

(which may be the same as yours but may not be) and I will send that to you- if you feel at that point its problematic and needs further discussion, I will set up a meeting. They do want to keep the 196 Sheridan for Mr Rando so its a question of minimizing confusion.
