Laurie,

For the Maine Muslim Community Center at 118 Anderson Street we received comments both from you and from Jenn Bartlett in the Fire Marshall's office.

This resulted in the decision to go with a wheelchair lift instead of a ramp. This lift is on the interior of the building, and is serving the building from the same location as the previously existing ramp.

We have also noted the inclusion of ventilation under the floor, as well as a seating plan that allows circulation to the stair and ramp.

Lastly, we've added a note that the ages of people using the space will be mixed and that it is not intended to be used for children only.
