On July 25, 2017, the Planning Board approved the construction of a three-unit residential building at 88 Walnut Street in the East End. As provided in Section 14-532, this letter serves as the written permission from the Planning Authority to commence on the property prior to the issuance of a building permit. The approved site work is limited to driving piles and installing the shoring system for the foundation. All work shall be done within the parcel property lines and outside of the City's right-of-way. All required erosion and sedimentation controls shall be installed prior to the start of site work.

Please be advised that you must obtain a demolition permit for the garage from the Permitting and Inspection Department prior to commencing the demolition. You must also obtain permits that may be required from Public Works for the temporary closing of any sidewalks and any temporary loss of on-street parking.

The approval to proceed with the site work is based on the submitted request from Jake Edwards' e-mail dated 10/11/17 (attached). If you need to make any modifications to the approved site plan, you must submit a revised site plan to Planning and Urban Development for staff review and approval.
