

1. N 20°44'17" W by said Washington Avenue a distance of Eighty-One and 71/100 (81.71) feet to a point;
2. N 24°36'47" W by said Washington Avenue a distance of Sixty-Nine and 02/100 (69.02) feet to a point at the southerly corner of land now or formerly of Fox Street, LLC as described in a deed recorded in said Registry in Book 32142, Page 229;
3. N 65°26'36" E by said land of Fox Street, LLC and land now or formerly of JP Sheridan, LLC (JP Sheridan) as described in a deed recorded in said Registry in Book 32142, Page 232 a distance of One Hundred Forty and 70/100 (140.70) feet to a point;
4. N 25°25'26" W by said land of JP Sheridan a distance of Eight and 15/100 (8.15) feet to a point;
5. N 65°43'04" E by said land of JP Sheridan a distance of One Hundred Twenty-Six and 57/100 (126.57) feet to a point on the westerly sideline of Sheridan Street;
6. S 30°21'34" E by said Sheridan Street a distance of One Hundred Ninety-Six and 82/100 (196.82) feet to a point at the northeast corner of land now or formerly of New Day Farm, LLC (New Day) as described in a deed recorded in said Registry in Book 32357, Page 220;
7. S 64°43'56" W by said land of New Day and said land of Cotton Street Holdings a distance of One Hundred Forty-Five and 13/100 (145.13) feet to a point;
8. N 21°57'21" W by said land of Cotton Street Holdings a distance of Twenty-Seven and 19/100 (27.19) feet to a point;
9. S 70°12'19" W by said land of Cotton Street Holdings a distance of One Hundred Forty-Nine and 04/100 (149.04) feet to the point of beginning.
