So here is a good one...there is a new permit application in for the above property (BLDC2020-01504). It is a 4-unit building, but the last legal use in UI is 2 dwelling units. A legalization permit was issued back in 2008, but it doesn't look like a CO was ever issued. There is a note on the last inspection for that legalization permit as follows:

"8/28/09 Clark S. Called requesting to postpone the 9/2 inspection until 9/16 due to unfinished work and door size order error. I granted this, but said that we will inspect at that date even if all violations have not been corrected. 9/16 Most violations corrected and some new ones noted, will reinspect for compliance. Some items will be corrected on the approved permits. JMB OUT 2:35"

Then there are other permits and numerous inspections over the next year or two, but looks like no final inspections on any of them? All the permits closed out by Vicky. There have been recent inspections by Chuck that have passed.

Thoughts on how to proceed? Is it too late to do final inspections on those old permits? Does he have to start again with a new ATF permit under current rules?

FLASHBACK!!! CLARK STEPHENS!! I'm including you Keri as we probably need to create a CO on an older permit if possible.

Thank goodness for diligence in note taking! So I checked further and the 08-0096 Legalization permit was issued on 2/9/11!! Here are my additional inspection results:

2/8/11: On 2/4/11 Clark called to postpone today's inspection to 2/7 or 2/8 and to review all the corrections. Clark S. Came into the office, I made a copy of the violations for him and reviewed. Also gave him a copy of the 1st floor plan for him to revise the bedroom layout for the legalization permit. He was approved to add a bedroom on permit #10-0828. 2/8/11 Met Clark on site, all violations corrected, signed legalization form and routed to fire for sign off. Asked Clark to produce the engineers letter for the structural roof repairs prior to issuance of the CO. OUT 1:12 jmb **4/8/11** Received letter from structural engineer, CO can be issued when fees are paid. Jmb From UI the Outstanding fees were: \$525.00

Check out the attached NOV I sent May 11, 2011 for a boarding house, I have no further info on this.

6/10/11: No inspection, 5/31/11 received proposal from attorney John Branson, gave information to Penny, emailed Tammy about it on 6/9/11. Danielle W-C left vcmsg on 6/10/11 inquiring about the next steps and I forwarded a vcmsg from John Branson for the same. 6/24/11 Consent Decree signed for this property, ok to issue CO pending fees paid. 8/22/11 returned a call to Clark inquiring about the date of the compliance inspection (2/8/11). Also reminded that CO has not been issued pending fees paid. Jmb

This type of string-a-long is this property owners MO. I was able to access the Groupwise emails about this and have saved this and the consent decree in the CBL, see attached. The consent refers to the property as a 4-unit dwelling.

I would take a guess that this just fell through the cracks, who knows if the fees were ever paid, UI was weak on that front, and the CO was not issued. At this point it is probably just a wash. There is also BLDC2020-01471 that is status Incomplete for 2 window replacements.

KERI>>> can a CO be created on permit 08-0096? If so, we shouldn't issue the permits until he at least pays for that!!
