Crawlspace:

Ground floor:

Removing interior

Removing and replacing the stair from the ground floor to the first floor

Removing interior gypsum board and wood paneling from the exterior walls and installing cellouse insulation and vapor barrier.

Adding 2x10's @ 16" to the ground floor ceiling and floor

Adding 2x6 framing to the exterior walls to allow for more insulation.

Adding Sprinkler system.

Running all new electrical outlets, light switches and lighting.

Removing the existing kitchen and moving to a new location on the west wall.

Adding 1 hour fire rated walls on the ceiling and stair walls.

Changing the bathroom layout and installing a new sink and bathtub.
