Good Morning Brad,

Please find the e-mail we received this morning from MDEP regarding the 7-Eleven Repair Projects at Congress St. And Washington Ave. below. MDEP has directed 7-Eleven to make these required repairs beginning no later than April 24, 2015. The work will be limited to replacing the existing pipe and sumps and the concrete, paving and electrical conduits associated with that. There will be no structural work since the existing canopies will remain at both sites. The petroleum work will be performed by State of Maine Licensed Tank Installers and will be inspected by MDEP as per the e-mail below.

We contacted the City of Portland Building Department because we will be replacing the paving and concrete pads noted in the attached drawings and wanted to confirm if the City of Portland would require any permits to be pulled for that replacement in kind work.

Mr. Brezinski with MDEP has stated that he would be happy to speak to the City of Portland Building Department if they have any questions regarding this work.

This is to inform you that today I have received removal notices for underground piping replacement and repair at these two Portland retail, motor fuels, underground storage tank (UST) piping. This UST

product piping at both locations noted above, and at the Brighton Ave facility, were found this past autumn 2014, to be out of compliance with Maine Chapter 691 Rules and required to be repaired and upgraded to compliance.

I understand that this piping work is expected to begin on 4/20/14, and 4/21/14. Maine DEP representative requires the opportunity to visit and examine the piping being replaced so please contact John Dunlap and I if there are any changes to these dates.
