- Designer qualifications (copy of NICET IV certificate or stamped plans and documents)
- Scope of work
- Wiring diagram(s)
- Annunciator details N/A
- Operations matrix

- Battery and voltage calculations
- Equipment data sheets
- A city electrical permit has been pulled

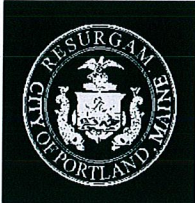
