Hi Laurie,

I was able to discuss your comments with my builder and revise the drawings. In summary:

A1 - Cross Section

This wall section has been updated with sizes and spacings for the studs, rafters and joists, R-values and sheathing thicknesses. The new dormer will be attached to the existing house with a 2x12-inch deep ridge pole. The addition will have a one piece rubber roof.

A4 - Proposed Floor Plan

This drawing has been updated with overall dimensions for the new dormer footprint and dimensions for the bathroom showing the R307.1 fixture clearances. The bedroom egress window has been labeled.

A6 - Door and Window Schedule

I have updated the window schedule to include the sliding bedroom window needed for egress.
