- **Permits expire in 6 months, if the project is not started or ceases for 6 months.**

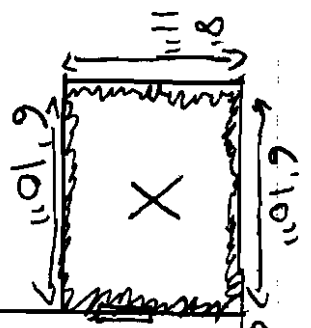

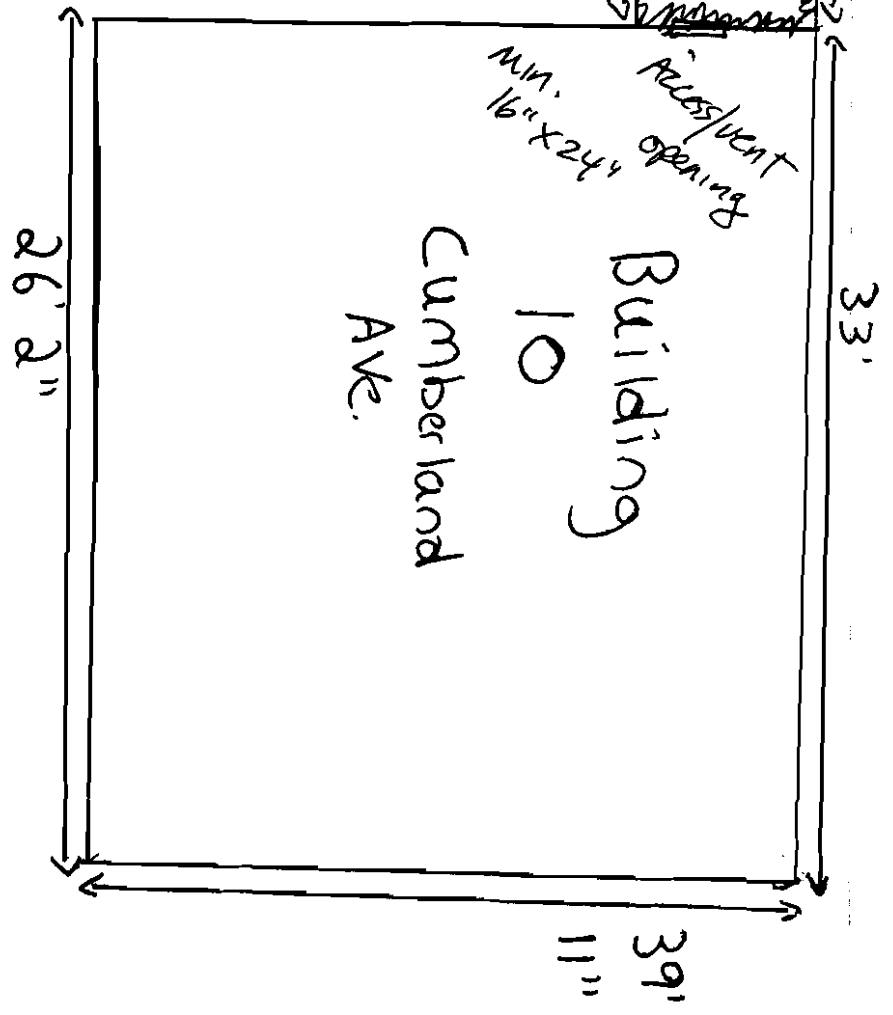
mm - Area of Project
