This project is an 8'x12' addition to the lower level unit of an existing two story 3 unit Dwelling.

Existing Unit 3 has one means of egress, and secondary means of egress including egress windows. A second egress exit door is being added.

An approved smoked detector and carbon monoxide alarm shall be installed outside of each sleeping area in the vicinity of of the bedrooms. Interconnected smoke detectors are existing in the building.


