

DESIGN



Permits: Each Contractor shall be responsible for all permits, fees, labor, equipment, etc. as may be required to complete their respective work category. Contractors shall forward to the Architect a copy of all approved permits, drawings and code compliance addenda with plan examiners comments within 48 hours of receipt of the same at no cost to the Architect. Any additional work required as a result of the above shall be provided by the Contractor as a part of his base contract and shall not become a basis for Change Orders or claims for additional compensation if the Contractor fails to comply with providing the approved plans or addenda to the Architect.

All construction indicated shall be new,

Preservative—treatment: All wood expreservative pressure treated wood.

All Contractors are jointly responsible to have entire area clean and spotless at time of turn over.

ntractors shall remove all construction debris related to k category from job site. All construction debris shall attained within limits of contract.

gles 90 degrees unless

rance: All Contractors shall obtain "all risk" insurance, as stipulated in the cification, and all customary statutory insurances, comprehensive eral liability, etc., as indicated in the project manual. The Architect and Owner shall be named as insured parties to the "all risk" insurance policy.

nentation / Record Drawings: The Contractors shall keep ord of all deviations from the contract documents. They shall neatly correctly enter in color pencil, any deviations on the drawings and "ications affected and shall keep the drawings available for inspection. tra set of construction documents will be furnished for the purpose.

Completeness: Any material or labor, neither shown on the drawings, nor specified, but which is obviously neccessary to complete the work of a similar nature or to comply with all applicable codes shall be furnished without additional cost to the Owner or the Architect. In the case of conflicting quantities/values, the greater amount or the one of greater value shall prevail and be provided by the Contractors as a part of his base contract and shall not become a basis for change orders or claims for additional compensation. In the case of conflicting or inconsistent information, the most stringent requirements shall prevail and be provided by the Contractors as a part of their base contract and shall not become a basis for change orders or claims for additional compensation.

The General Contractor shall distribute complete sets of drawings to all subcontractors. Do not separate drawings by disciplin DO NOT SCALE DRAWINGS.


