

As requested by the Code Enforcement Officer of the City of Portland this letter addresses the existing roof joists at the above referenced site and their capacity to support the design loads of IBC 2003 and the imposed loads of the proposed roof top units.

The joists in question consist of 14" steel joists spaced at approximately 4 feet on center spanning between structural I beams. According to IBC 2003 Portland is in a ground snow load of 50 psf which translates to a flat roof snow load of 35 psf. Based on the design drawings prepared by Shelley Engineering, Inc. dated October 5, 1998 the design ground snow load was 60 psf which translated into a flat roof snow load of 42 psf. As such, the joists are able to support the design loads prescribed by IBC 2003.

In regards to the joists and their ability to support the proposed roof top units, I have reviewed them based on the roof top unit locations, footprints, and weights as shown on Moeser & Associates drawing A1.3. Provided the roof top unit locations and weights do not change significantly the existing joists are adequate to support the additional weight of the units.
