EXHIBIT "A"

A certain lot or parcel of land situated on the Northerly side of Monument Street in the City of Portland, County of Cumberland, State of Maine and further bounded and described as follows:

Beginning at a point on the Northerly side of Monument Street that is distant Northeasterly measured along said Monument Street 96 feet from the Northeasterly corner of Monument Street and Atlantic Street;
