I have an application in review to replace an existing chain link fence with an 8' wooden fence. Thank you for your patience on this. If I measure from the curb to the fence then it is more than 25' but if I measure from the sidewalk it is only 22'. How should I proceed? I see that a brand new house on Monument built a brand new 8' fence well within 25' of the front property line. Is there a workaround for us?

Hi Tyler,

Just looking at your fence application now. Can you verify the measurement between the front property line and the closest point of the fence? The rules restrict any portion of a fence that is within 25' of a front property line to a height of 4' or less. The existing fence looks really close to 25' on the air photo, if you can confirm that it will be at least that far back, you will be all set. If it is less, I would have to run it by public works before approval.
