

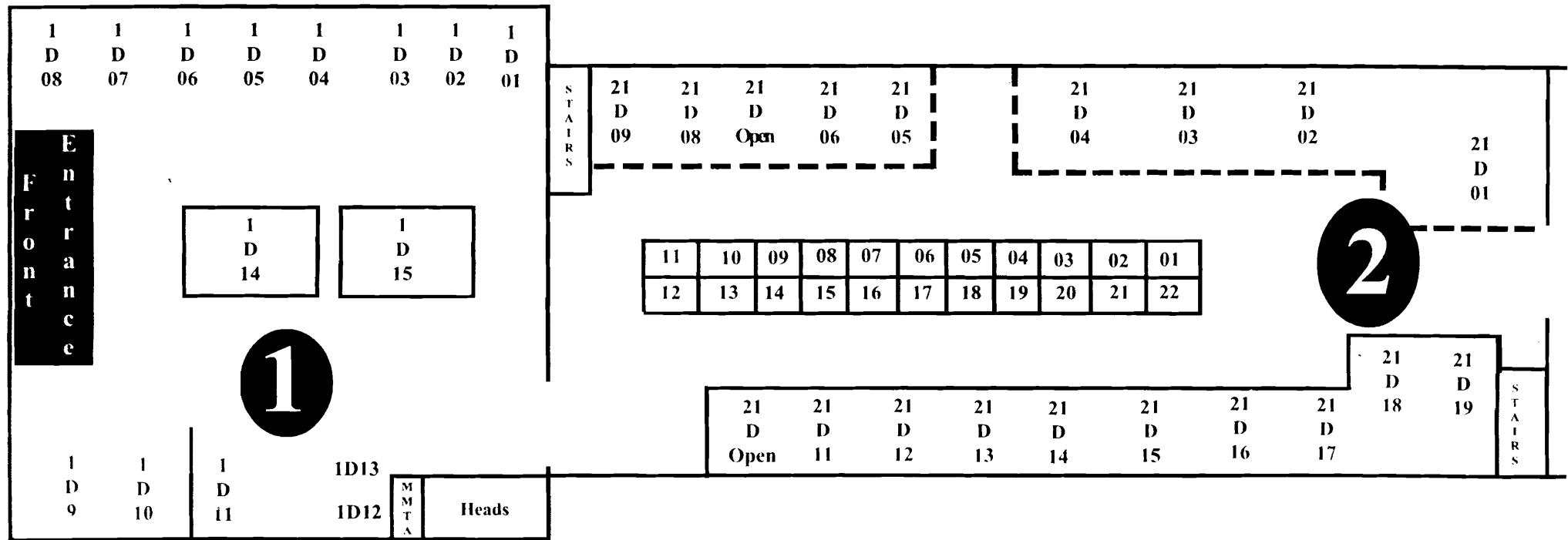

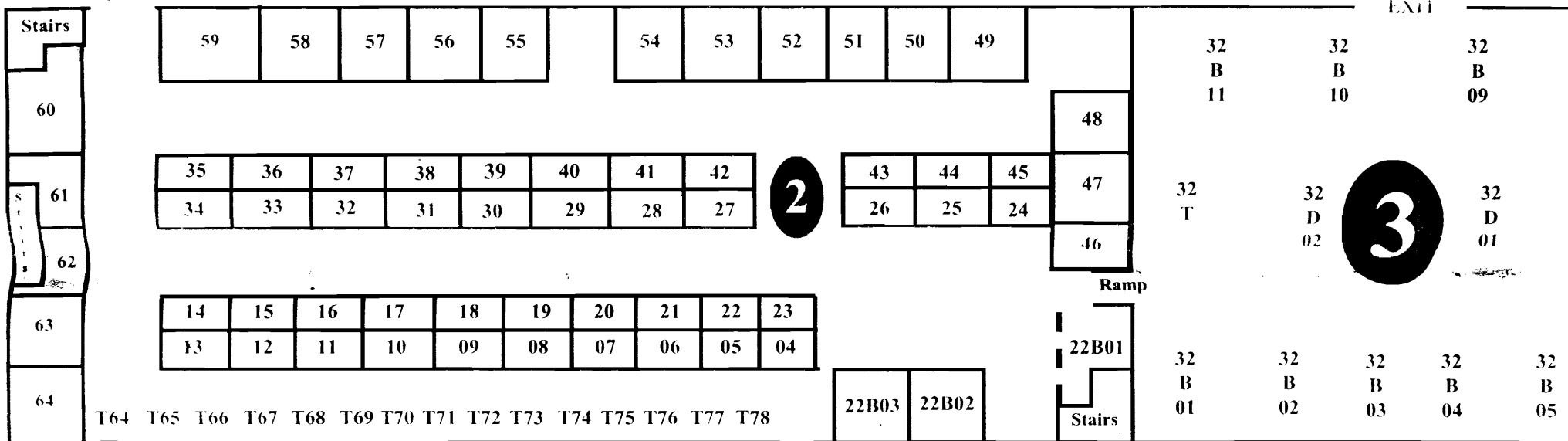

MAIN ENTRANCE, FIRST FLOOR BUILDINGS 2 AND 3

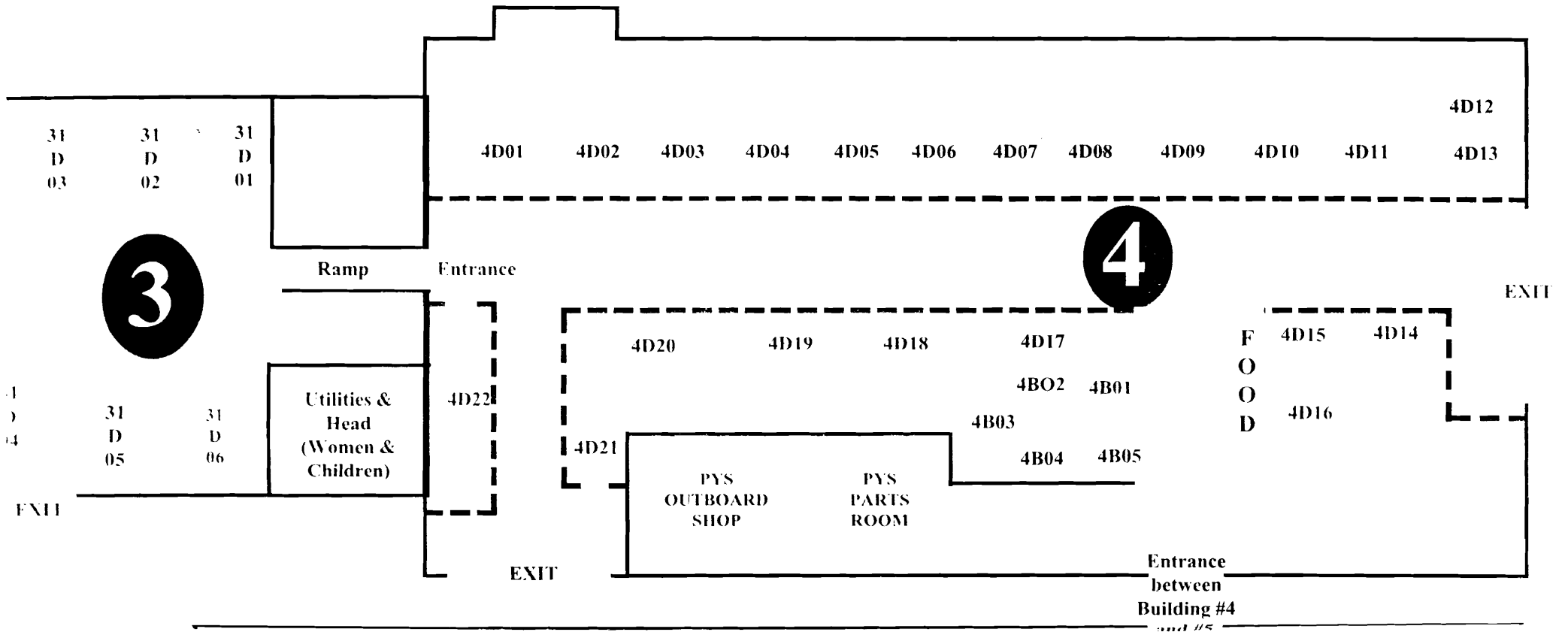

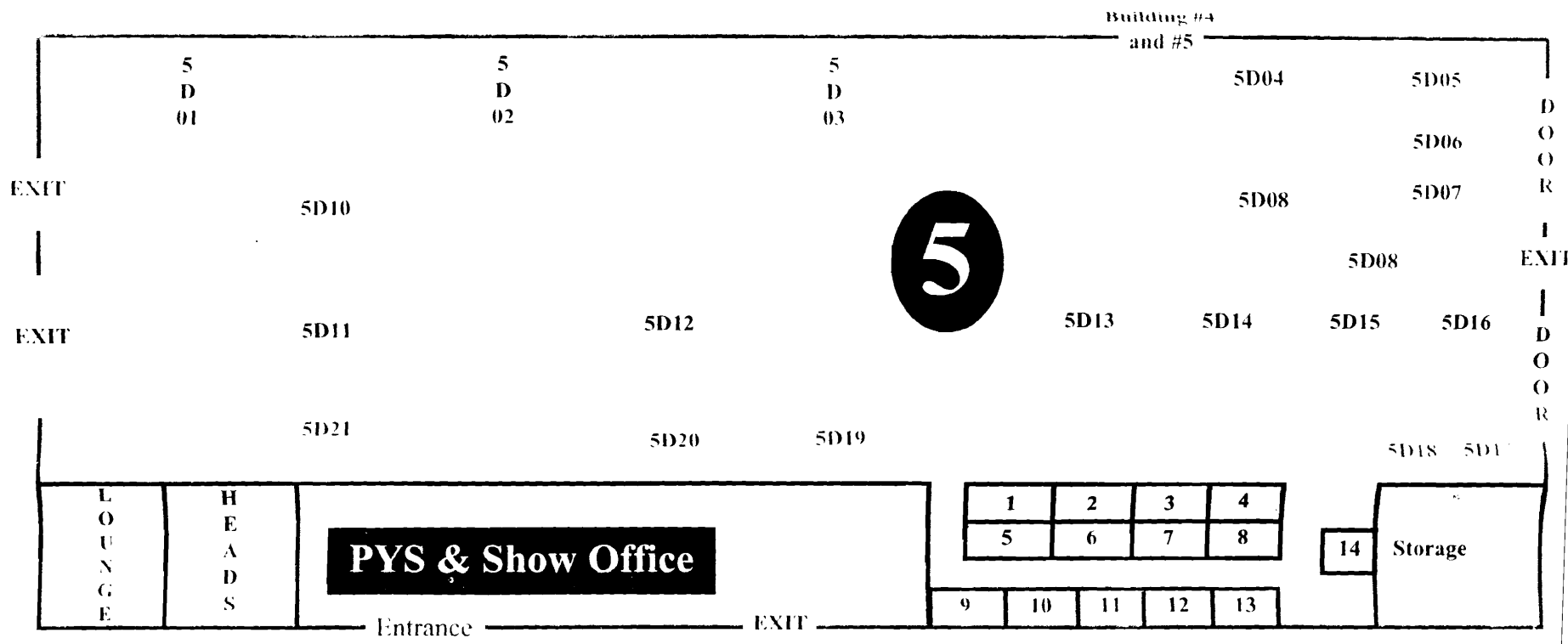
FIRST FLOOR - BUILDING 4
