Revisions: Relocate all bike racks (5) to one central location adjacent to the drop-off circle, reduce size of adjacent landscape bed, increase # of plants in three landscape beds adjacent to hotel entry and central turning circle, relocate street light from intersection of Thames/Hancock Streets to in-line with others proposed along Thames Street, adjust curved step radius and termination point along Thames Street, reconfigure street trees and seatwall (adjacent to steps) along Thames Street, and remove streetscape improvements along Fore Street, south of entry driveway, from hotel project (3 street trees, 1 street light, and brick sidewalk - to be installed with development of Lot #2).
