The project includes the construction of a 6-story mixed use (retail and residential) structure at 20 Thames Street in Portland with an estimated water usage of 5,200 gallons per day. There is currently an 8-inch DI fire line and a 6-inch domestic water service from the 10" line in Thames Street that terminates at the property line and is available to service the property. The lines were initially installed in an anticipation of a previous project that did not move forward. The location of the proposed building in relation to the existing lines would limit the use to the 8-inch fire lane in a parent/child configuration with a 6-inch fire service and a 4-inch domestic service.
