Section 4452. This is an appealable decision pursuant to Section 12.80 of the Municipal Code.

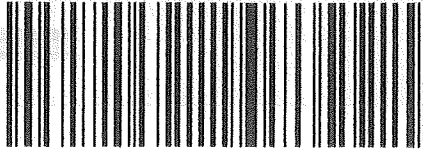

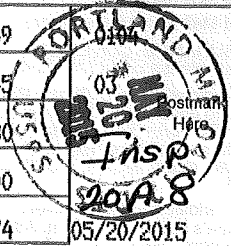
