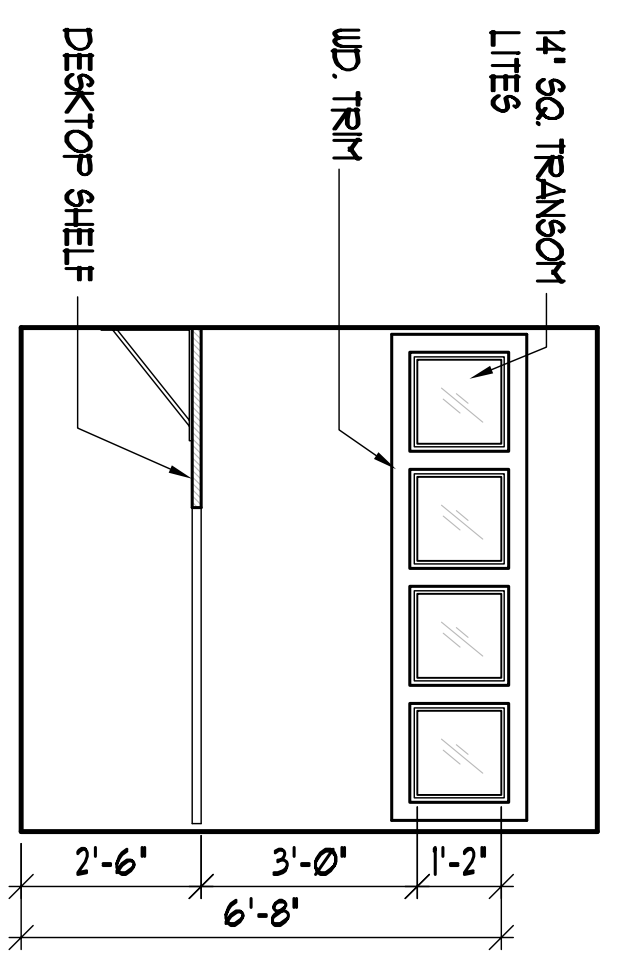
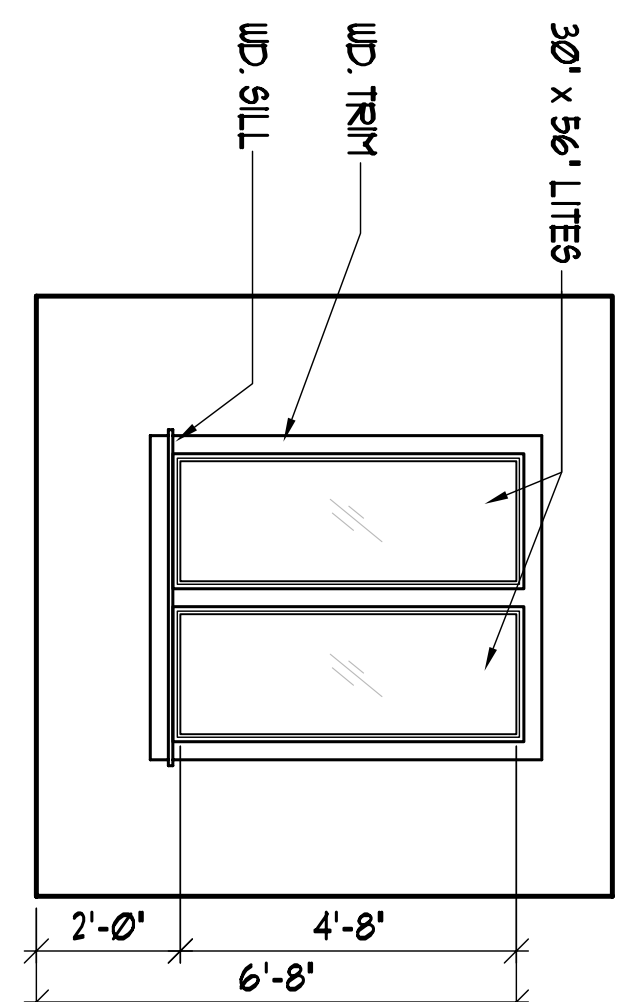


1 FIRST FLOOR PLAN

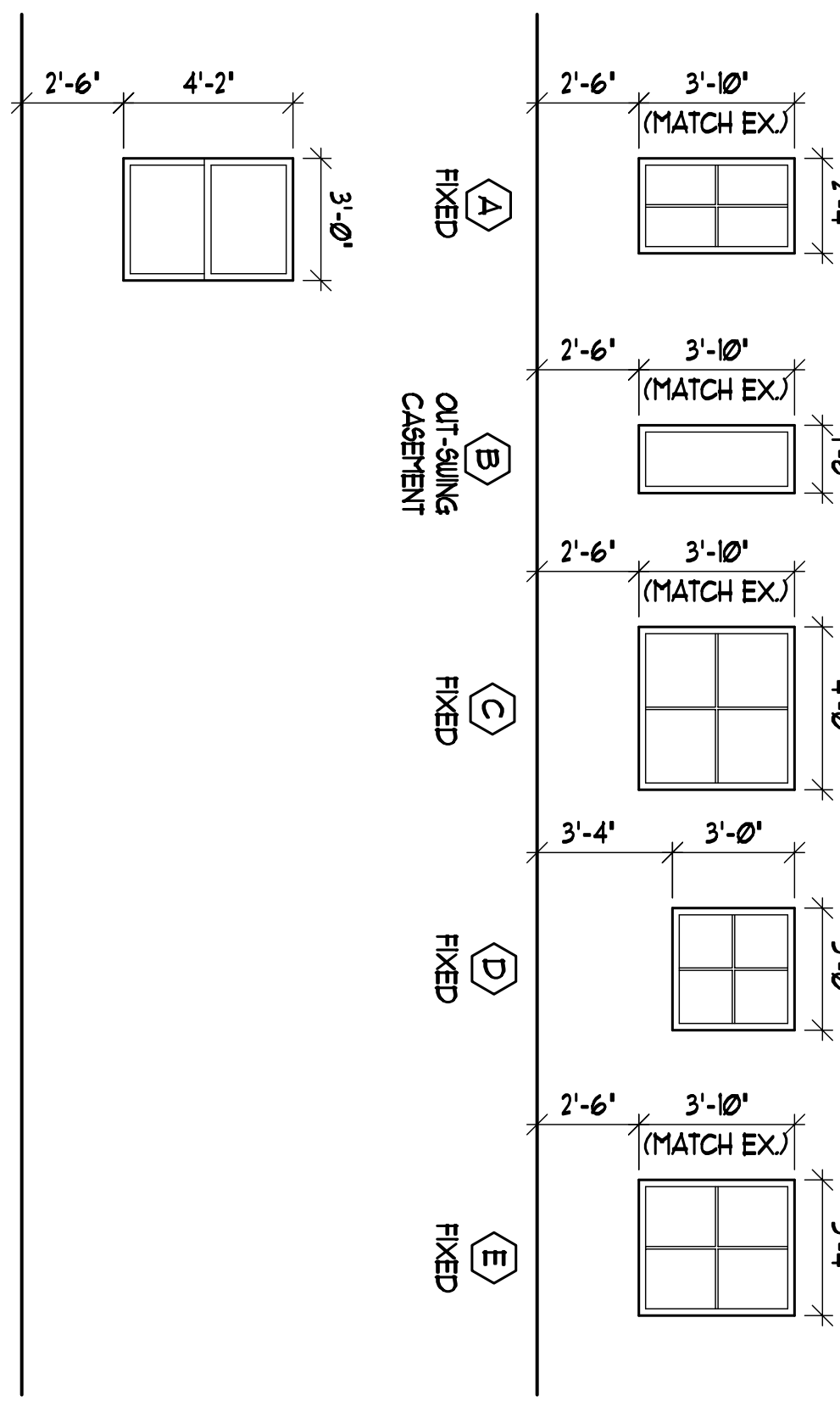


4 INTERIOR ELEVATION

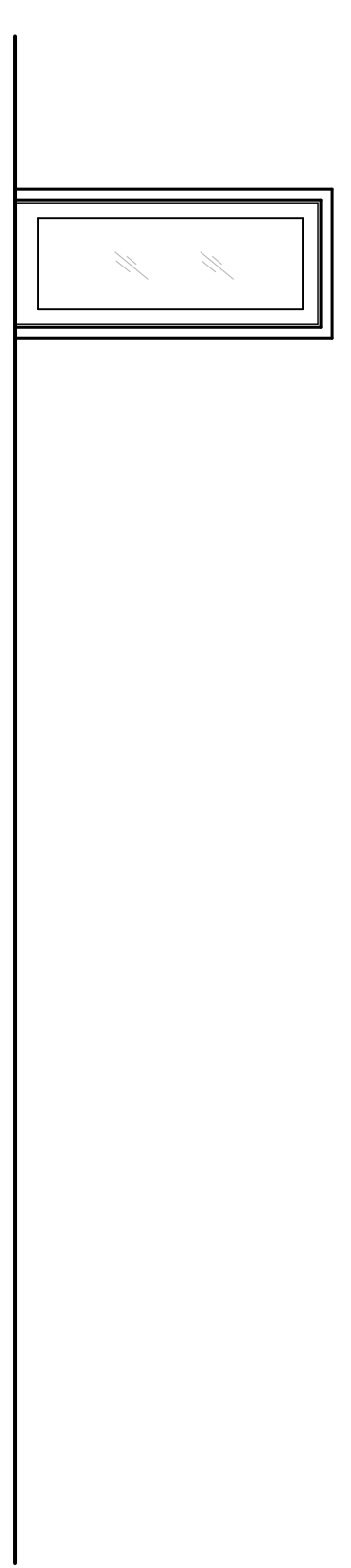
FLOOR PLAN NOTES

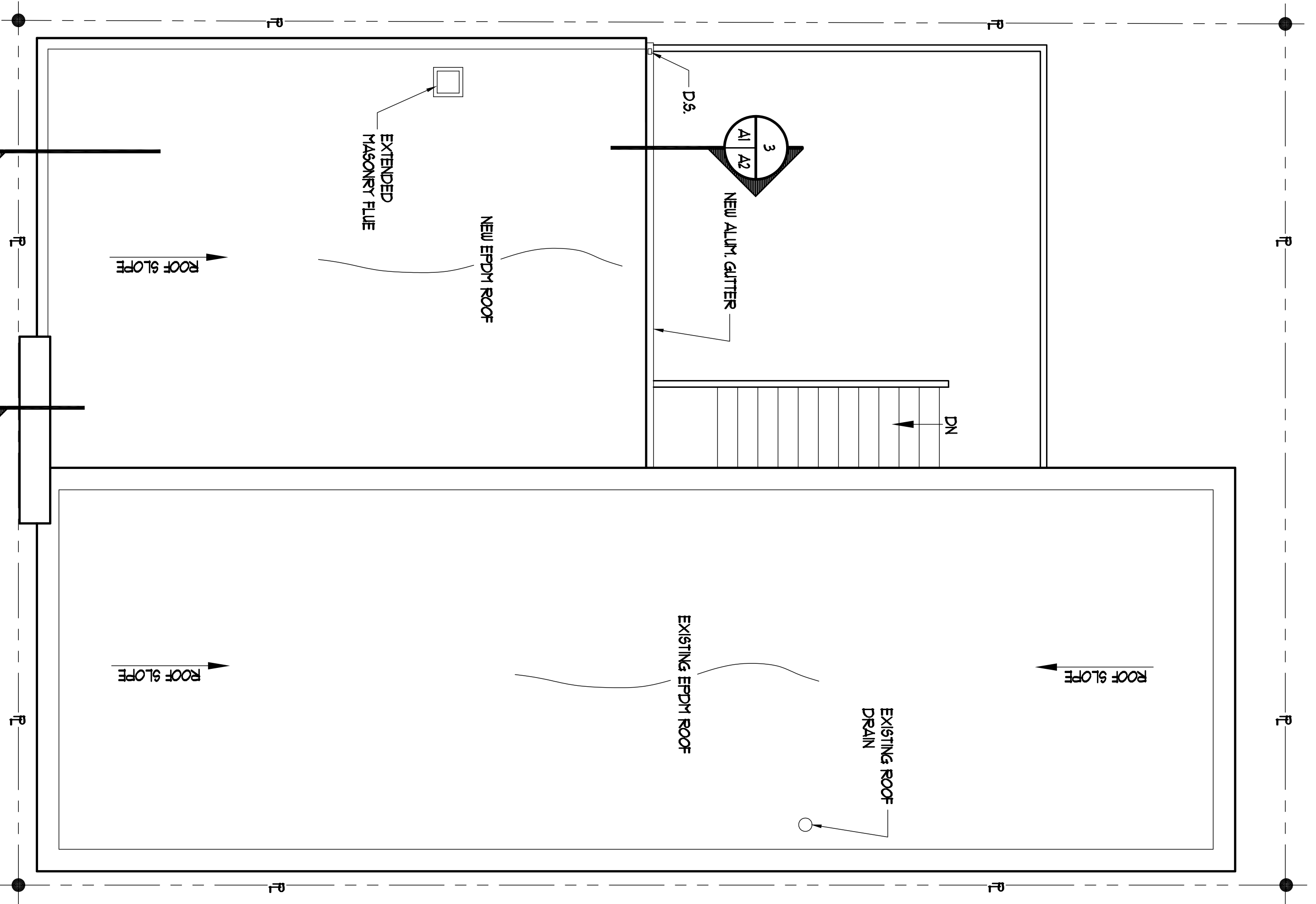

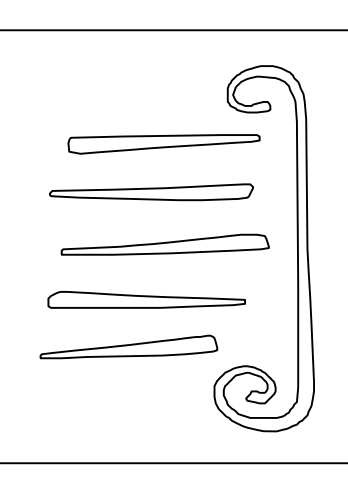
