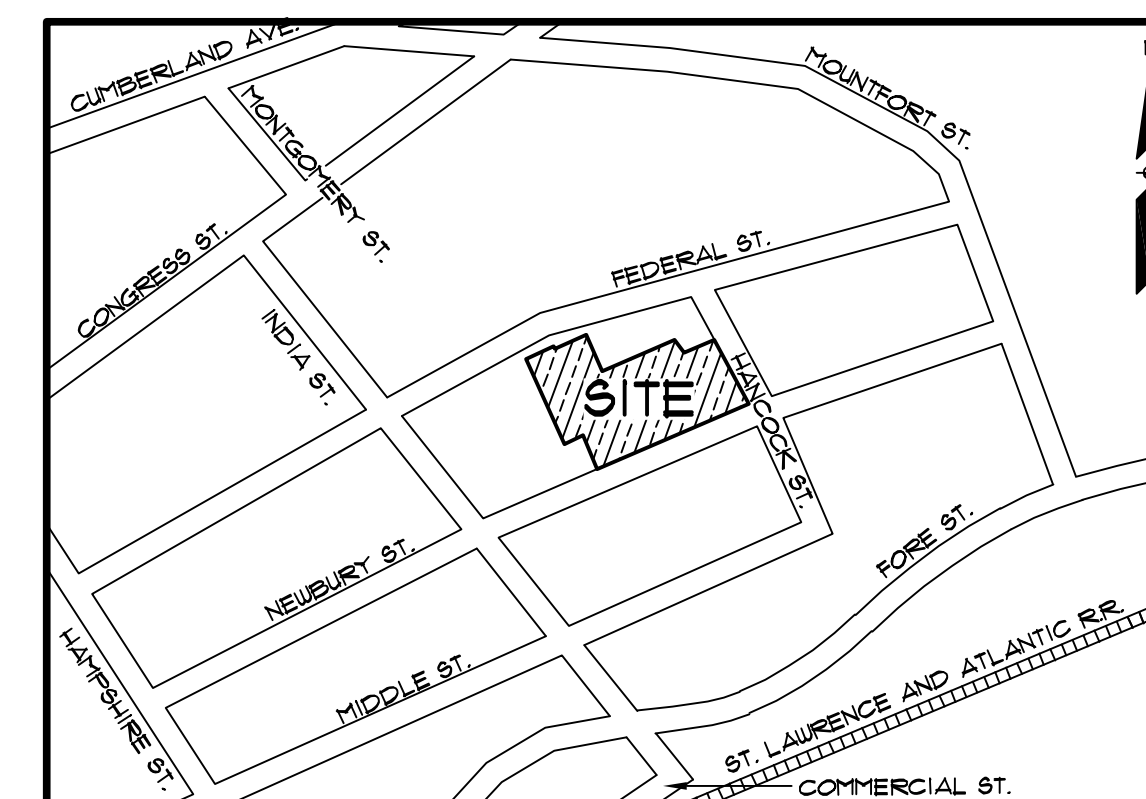
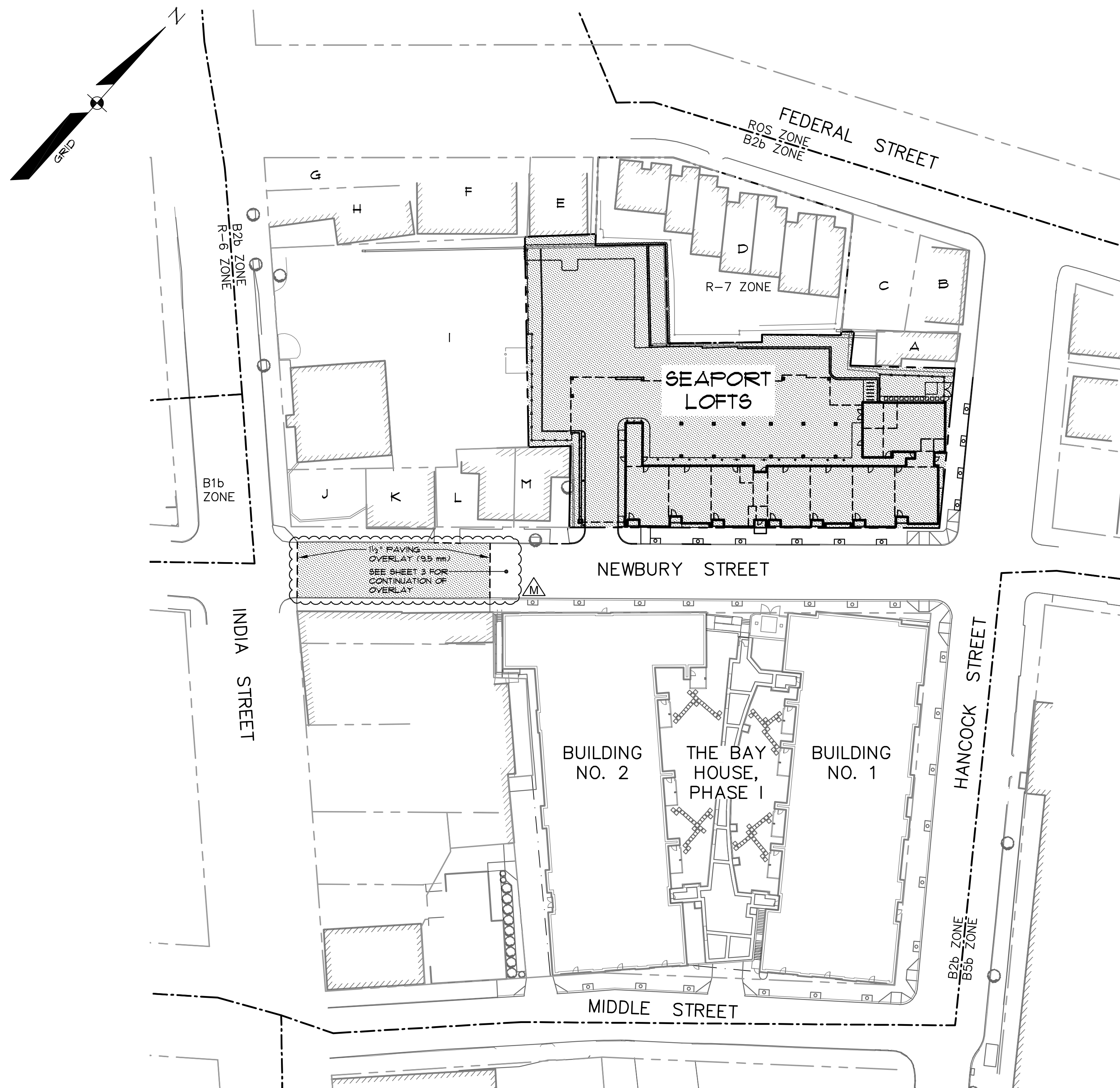

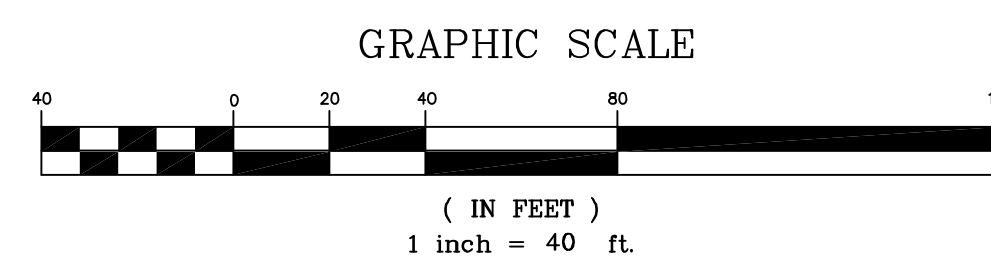


LOCATION MAP
