MEMORANDUM OF GROUND LEASE made as of this 5th day of October, 2016, pursuant to 33 M.R.S.A. §201 with respect to the following described Ground Lease:

DATE OF GROUND LEASE: October 5, 2016.

NAME OF LANDLORD: EIGHT MIDDLE LAND COMPANY LLC, a Maine limited liability company with a place of business and mailing address at c/o Shipyard Brewing Company, 86 Newbury Street, Portland, ME 04101.

NAME OF TENANT: 16 MIDDLE STREET ASSOCIATES, LLC, a Maine limited liability company with a place of business and mailing address at 470 Fore Street, Suite 400, Portland, ME 04104-3571.

DESCRIPTION OF LEASED PREMISES: A certain lot or parcel of land with all improvements thereon and rights appurtenant thereto, situated in Portland, County of Cumberland and State of Maine, at 16 Middle Street (formerly 8 Middle Street), bounded and described on Exhibit A, attached hereto and incorporated herein.

TERM AND OPTION TO RENEW: The Commencement Date of the Ground Lease is October 5, 2016.
