

Replace damaged ceilings for first floor kitchen, first floor bathroom, first floor living room, second floor kitchen, second floor bedroom #1, and third floor bedroom #2 with 5/8" Toughrock Fireguard gypsum board

Replace or repair other damaged drywall with standard 3/8" sheetrock

Reframe header of door entry for second floor bedroom #2

Replace existing apartment front and rear entry doors with same size steel 60 minute fire rated doors

Replace front stairway handrails

Note: All work involves repairing existing walls and structure with no new construction.
