RE: WAIVER REQUEST for Signage, 161 Marginal Way (Maine Eye Center, tenant)


Dear Ms. Stacey:

This letter serves as a request for a Staff Waiver from the sign illumination standard outlined in Standard E-16 of the City of Portland Design Manual. A check for \$75 is included, as requested. Specifically, we request to use *face-lit signage*, as illustrated on the attached drawings. It's our belief such signage will not detract from the character of the district, while making it easier for patients to navigate to the new practice locations. Further, because of limited behind-the-wall access, halo-lit letters (per the Standard) would require the use of a fabricated background to allow for illumination. The resulting appearance might not be in keeping with the intent of the standards.

For comparison, a photo survey of neighboring face-lit signage in this B-7 Zone is included. You'll see the proposed signage is in keeping with the scale, style and lighting of other signage on Marginal Way, some of which has been recently installed.




