Her name is Kimberly Mitchell, and she lives at 9 cedar St # 3, in Portland - The owner is Harry Kringman. My mom contacted the manager Harry Kringman + John Jensen in regards to her new couch being loaded with Bed Bugs. The building manager John said "Im not around", and hung up on her. It's been two weeks since, the landlord + property manager are ignoring phone calls, + doing NOTHING to try to resolve the issue. Now, my mom's brand new bed is that she got a few months ago, is loaded. Her unit isn't the only one, and many tenants have moved out, because of these bugs. Not to mention the building is also infested with roaches.

This is all really saddening to me. My mom pays \$935.00 in rent, & it isn't easy finding an apartment.
