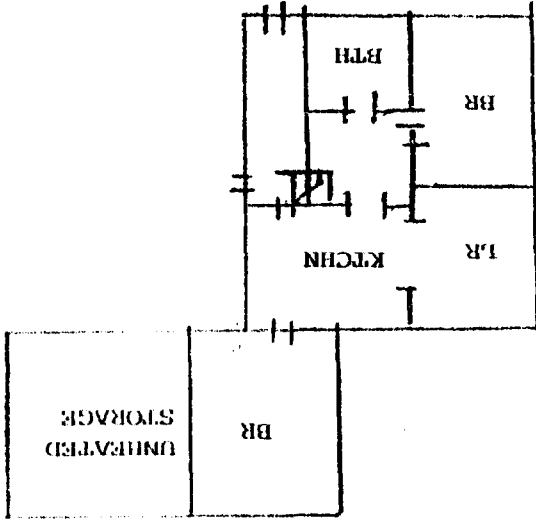


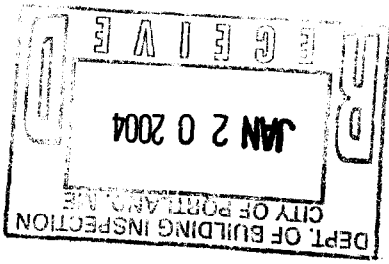
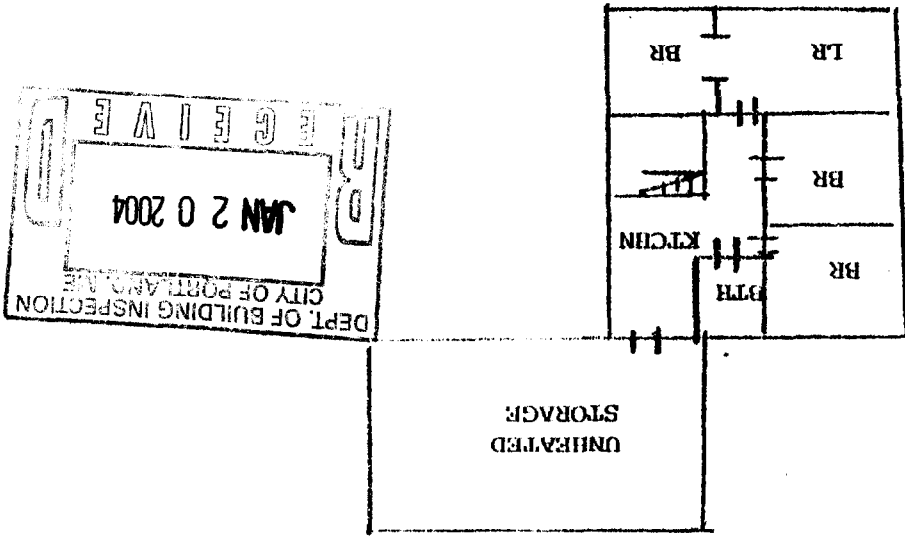

(UNIT #1)



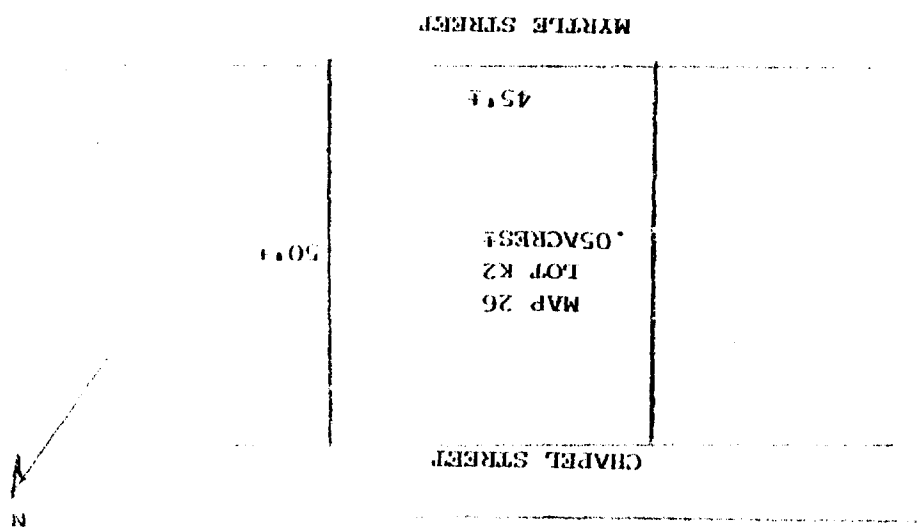
SECOND FLOOR

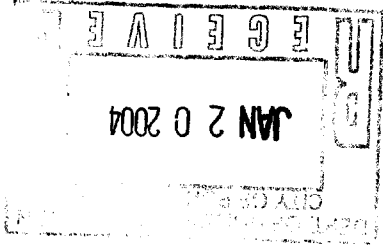
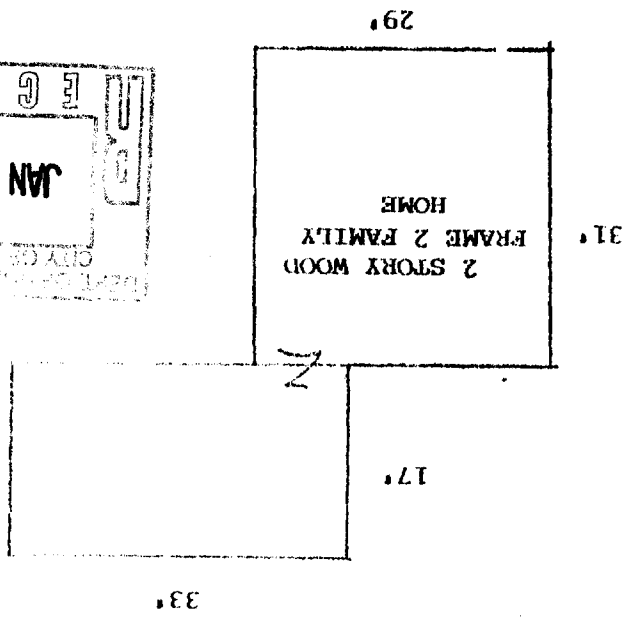
PLOT PLAN

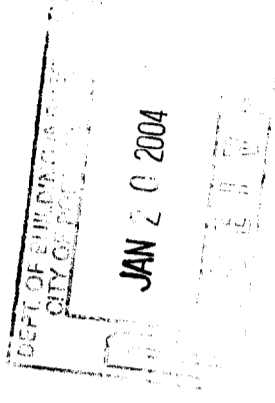
BUILDING PLAN
