


**QUITCLAIM DEED WITH COVENANT**

A certain lot or parcel of land, with any improvements thereon, situated on the northeasterly side of Chapel Street, in the City of Portland, County of Cumberland and State of Maine, and being numbered forty-seven (47) thereon, bounded and described as follows:

Beginning at the westerly corner of land now or formerly of Patrick Stone; thence northeasterly, a distance of fifty (50) feet, more or less, to land now or formerly of J.M. Gould; thence northwesterly by land now or formerly of Gould, a distance of thirty-seven (37) feet, more or less, to land now or formerly of E.P. Chase; thence southwesterly by said Chase land and the center of the partition wall which separates the two houses building upon this and the adjoining Chase lot, a distance of fifty (50) feet, more or less, to said Chapel Street; thence southeasterly by said Chapel Street, a distance of thirty-five (35) feet, more or less, to the point of beginning.

Also another certain lot or parcel of land, with any improvements thereon, situated in the City of Portland, County of Cumberland and State of Maine, bounded and described as follows, to wit:

Beginning at a point on the northeasterly side of Chapel Street, which point is made by the junction of Chapel Street with a lot formerly owned by Thomas Warren and on the northwesterly side of the lot hereby conveyed; thence adjoining the southeasterly side line of said adjoining lot on a northeasterly course, approximately fifty (50) feet to land now or formerly of Nathan Howe; thence southeasterly by said Howe's land and land now or formerly of Edward Gould to the center of the block of two (2) houses, one of which being the northwesterly one which is hereby conveyed; thence southwesterly through the center of said block to the line of Chapel Street; thence northwesterly by said line to the point of beginning.

This conveyance is made subject to any and all easements and appurtenances of record, insofar as the same may affect the subject premises.
