
Dear Mr. Wallace,

At your request, we have reviewed the loads for the HVAC equipment to be installed at 28 Monument Square.

The air handler weighs approximately 950 pounds, according to the data you provided. It will be suspended from the ceiling of the first floor, in the right rear corner. A typical hanger system of two - 2 inch by 2 inch steel angles, one at each end of the unit and extending at least two feet to each side of the unit such that each angle is attached to at least five (5) joists is adequate. The angles should be attached to each joist with a minimum of one $3/8 \times 3$ lag bolt and a metal U shaped strap that wraps the angle and is attached to each side of the joist with two $\frac{1}{4}$ x 1 wood screws at least 4 inches from the bottom of the joist.


The compressor weighs approximately 750 pounds. It will be located on the second floor roof, at the rear of the building. Sleepers at least four (4) feet long should be used at each end of the unit. The unit should be located within 10 feet of the center of the building. The unit should be attached to the sleepers to prevent movement. We have evaluated the capacity of the roof joists and determined that they are adequate for this load.


