Hi Doreen,

Could you ease give me a call on my cell phone so we can sort this out, 978-821-4954? The building permit I sent you is for the renovation and addition and the cost of work is 5.6 million dollars, not \$5,600. Per suggestion of Jeannie, the fast track interior demo permit was resubmitted as a separate email with its own building permit application. As the cost of demo was covered under the overall scope, that line in the form references the overall building project and doesn't include a cost. Jeanie noted there would be a \$25 review fee for the fast track review, but only the \$25 as the rest of the cost was covered in the full permit.
