Ted and Troy, attached (image 375) is the layout we have come up with, based on vendor registrations. As you had suggested/requested, we've gone with more 10 x 10 canopies and fewer 20 x 40 tents. You guys were on target with that, since we had around 20 vendors sign up for the 10 x 10s and it gives us a nice wide clear runway down the middle of the square.

We also have re-oriented two of the 20 x 40 tents to have the ends pointed toward the "runway" so as to draw people in, rather than the previous layout in which the $20 \times 40 \text{s}$ had their long sides towards the runway.

I think this layout is an improvement over the last one by using space more efficiently, allowing for more openness than the previous layout, which I've also attached (image 376).

Our team is meeting today from 3-5 pm to finalize this. If you have any thoughts before then, please let me know.
