Hi Rob,

These are permit applications for two renovations (units 5 and 23) we are doing at 312 Congress Street. We plan to replace the old windows which are no longer operating correctly with white vinyl replacement windows, same as the ones you had approved on the other side which faces the parking lot. The windows on these units face the buildings on Hampshire Street and towards the rear of the building away from Congress street (opposite side as the parking lot which runs along Franklin) and are not visible to the public, there is a small strip between the properties, but no alley and the buildings are only about 10 ft apart so cannot be seen from any street.
