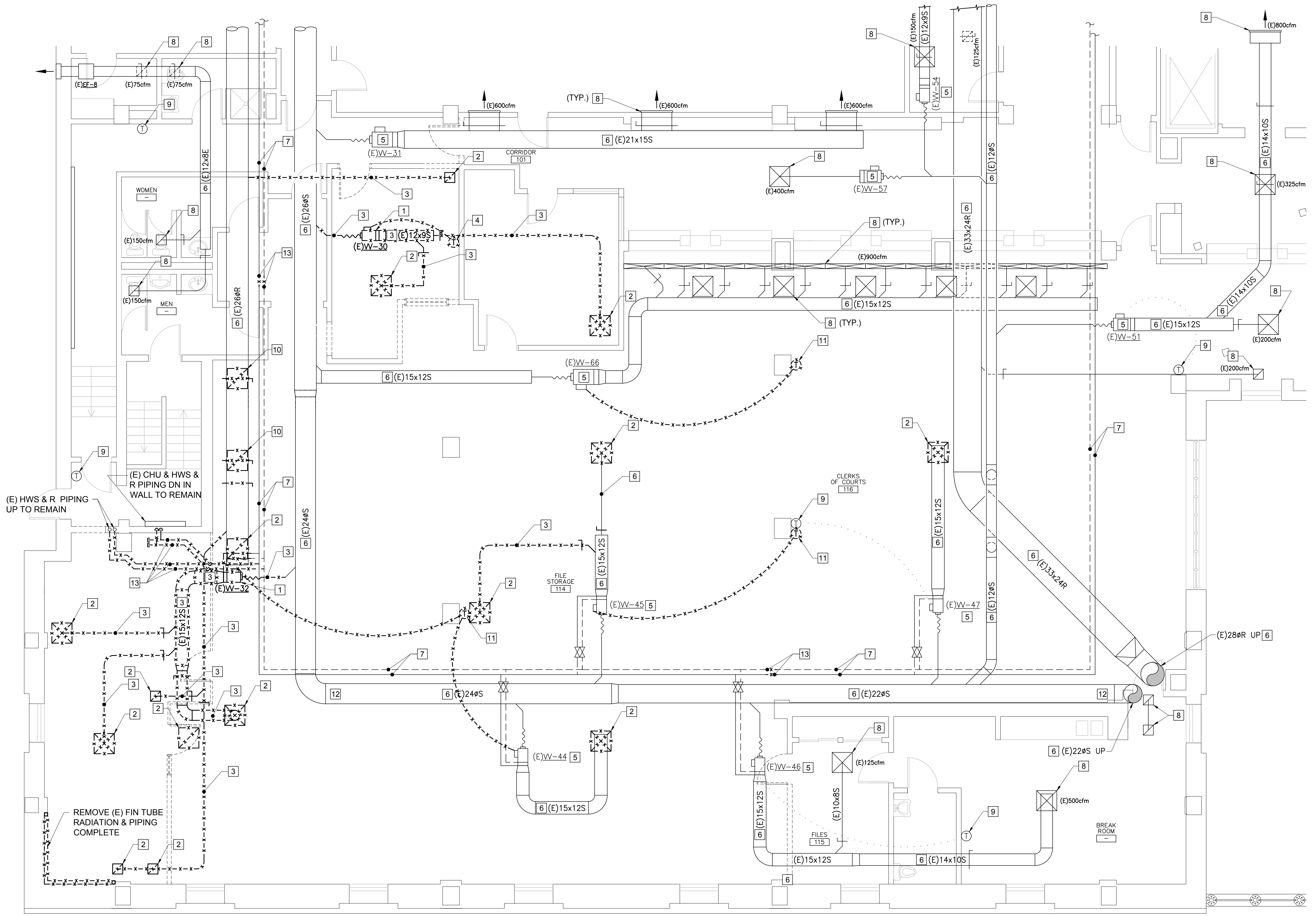
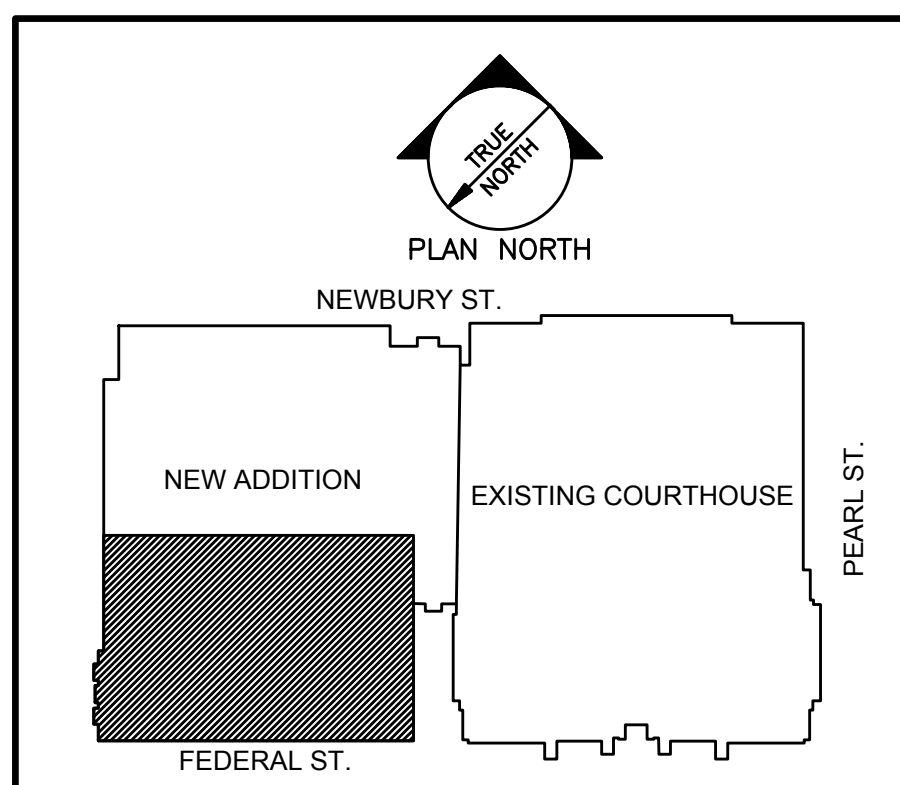

- KEYED NOTES:**
- 1 REMOVE EXISTING VAV BOX, AND ASSOCIATED DUCTWORK, PIPING AND CONTROLS COMPLETE. TURN OVER VAV BOX TO OWNER AFTER REMOVAL.
 - 2 REMOVE EXISTING DIFFUSER/GRILLE AND ASSOCIATED DUCTWORK COMPLETE. TURN OVER ALL RDGS TO OWNER AFTER REMOVAL.
 - 3 REMOVE EXISTING DUCTWORK COMPLETE.
 - 4 REMOVE EXISTING TSTAT COMPLETE.
 - 5 EXISTING VAV BOX TO REMAIN.
 - 6 EXISTING DUCTWORK TO REMAIN.
 - 7 EXISTING PIPING TO REMAIN.
 - 8 EXISTING DIFFUSER/GRILLE TO REMAIN.
 - 9 EXISTING TSTAT TO REMAIN.
 - 10 RELOCATE EXISTING DIFFUSER/GRILLE.
 - 11 RELOCATE EXISTING TSTAT. REFER TO SHEET MP1 FOR NEW LOCATION.
 - 12 CONTRACTOR SHALL TRAVERSE THE EXISTING SUPPLY DUCT PRIOR TO INITIATION THE DEMOLITION WORK TO DOCUMENT THE EXISTING FLOW FOR REPLICATION DURING FINAL AIR BALANCE. MEASUREMENT SHALL BE TAKEN WITH ALL CONNECTED VAV TERMINALS AT FULL COOLING CALL.
 - 13 REMOVE EXISTING HWS & R PIPING. THE EXISTING CONTROL VALVE, ISOLATION VALVES, AND BALANCE VALVE SHALL BE RELOCATED AS INDICATED ON SHEET MP1.
