Virginie,

Can you please confirm the following:

- All plans should be stamped including the code analysis and life safety plan. The attached code
 analysis and life safety plan are stamped. I bubbled any changes since the last drawings I sent you.
- Provide occupant load calculations in the code analysis. The occupant loads are located is section 1005. I pulled out the fitness room as a separate occupancy (I clouded this section so it is easy to find)
- The fitness center on the first floor looks to be greater than 10% of the floor area. Clarify how you justified this being an accessory occupancy. You are right that the floor area is greater than 10%. I pulled the fitness room out of accessory occupancy and created it as separated use. Per table 508.4 we don't need any separation between the garage S-2 and fitness room A-3.

• Clarify total number of residential units in the building. We have 24 units in the building. Since we are only going for the foundation permit we didn't submit any drawings not related to the foundation. By doing so we know we are at risk of not complying with any code items that come up during the building permit review, but the owner is willing to take this risk. Next Monday July 18th we will be submitting all the drawings for the building permit application. In these you will see that the units have been reduced from 26 (latest Form Based Code Submission) to 24 units. We have made Caitlin Cameron aware of this change and on Monday we will be submitting drawings to Caitlin and planning staff as well.




