Appointments must be requested 48 to 72 hours in advance of the required inspection. The inspection date will need to be confirmed by this office.

- **Permits expire in 6 months. If the project is not started or ceases for 6 months.**

1) Provide fall protection around the (building's basement or lower level) window, or door wells located within the sidewalk. 1013.2 Height. Required guards shall be not less than 42 inches high, measured vertically above the adjacent walking surfaces, adjacent fixed seating or the line connecting the leading edges of the treads. Guards shall not have openings from the walking surface to the required guard height which allow passage of a sphere 4 inches in diameter.				
2) The outdoor seating may not be used until the permit is issued and posted on site.				
3) This permit approves outside seating only. Any alcohol or entertainment in this space requires licensing approvals from the City Clerk.				
4) The outside dining permit is approved for the area delineated at the inspection and stated on the permit, and must be kept on site. This permit for the use of outdoor seating expires on 05/05/2017.				
5) The tables and chairs must not block any means of egress of any building, even during storage.
