

Be sure to include distance from the ground and building façade dimensions for any signage attached to the building.

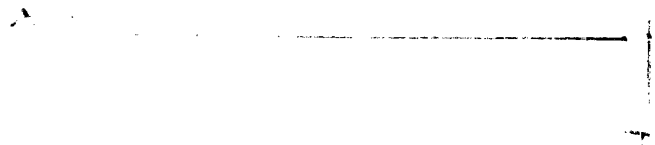

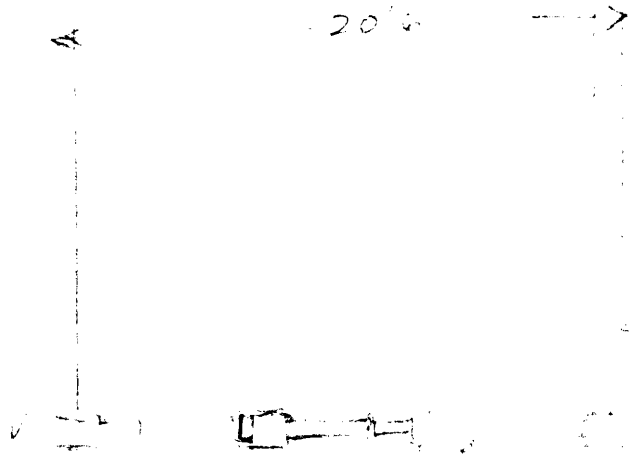
