- 1) Current test documents shall be provided upon final inspection for all NFPA 25 required testing.
- 2) Drawings shall be provided on completion of the project to document changes to the sprinkler lay out and heads that were installed.
- 3) Notice: The first scheduled final inspection fee is at no charge. Additional inspections shall be billed at \$150 for each inspector.
- 4) Through-penetrations and membrane penetrations in fire walls, fire barrier walls, and fire resistance rated horizontal assemblies shall be protected by firestop systems or devices in conformance with NFPA 101:8.3.5 (ASTM E 814 or ANSI/UL 1479). Providing firestop labels at each firestop system or device and an onsite manual containing the detail for each firestop system or device used for the project will streamline final inspection approvals.
- 5) A Knox Box is required.
- 6) The entire sprinkler system shall be maintained in accordance with NFPA 25, Standard for Inspection, Testing and Maintenance of Water-Based Fire Protection Systems, 2008 edition.
- 7) System acceptance and commissioning must be coordinated with a fire alarm technician and suppression system contractors and the Fire Department. Call 874-8400 to schedule.
