GENERAL REFLECTED CEILING PLAN NOTES

- . ALL CONDUIT, MC CABLE, TEL/DATA WIRING, etc. LOCATED IN EXPOSED CEILING AREAS ARE TO BE MOUNTED, ROUTED AND BUNDLED IN A NEAT AND PROFESSIONAL MANNER, AND COORDINATED WITH ALL MECHANICAL, PLUMBING AND SPRINKLER ITEMS IN EXPOSED CEILING
- . CENTER ALL SPRINKLER HEADS, LIGHTS & FIXTURES IN CEILING TILES.
- 2. LIGHTS ARE SHOWN TO HELP ESTABLISH RELATIONSHIP OF SPRINKLER HEAD LOCATIONS TO OTHER CEILING ELEMENTS. FOR INFORMATION ON ALL CEILING AND WALL MOUNTED LIGHT FIXTURES AND DEVICES, REFER TO ELECTRICAL DRAWINGS AND CUT SHEETS.
- 3. REFER TO ELECTRICAL DOCUMENTS FOR ADDITIONAL LIGHT FIXTURE INFORMATION.
- 4. LIGHT FIXTURE LOCATIONS AND QUANTITIES ARE THE RESPONSIBILITY OF THE DESIGN BUILD ELECTRICAL ENGINEER. ENGINEER TO ENSURE THAT THE LIGHTING LEVELS MEET ALL APPLICABLE CODES.
- 5. LIGHT FIXTURES SHALL BE LOCATED IN THE CENTER OF THE STAIR LANDINGS.

- 3. DIMENSIONS ARE TAKEN FROM COLUMN CENTER LINE AND FROM PARTITION CENTER LINE. CLEAR DIMENSIONS ARE TO THE FINISHED FACE OF NEW CONSTRUCTION AND SHALL TAKE PRECEDENCE OVER ANY OTHER DIMENSION.
- 4. REFER TO SHEETS A4.60 A4.61 FOR WALL PARTITION TYPES AND RATED ASSEMBLIES.
- 5. REFER TO SHEET A6.2 \$ A6.4 FOR DOOR SCHEDULES AND DOOR DETAILS
