Dear Eleven Exchange LLC,


After evaluating your properties on several occasions, and providing multiple notices of the unsafe condition at your buildings (1-9 Exchange Street), they remain in violation of Municipal Code, 25-174.

Section 25-174(A)(1) provides quite clearly that it your duty to remove all accumulations which pose a threat of falling onto streets or sidewalks. This has happened twice, and given the upcoming warming and melting cycle, there is risk it will happen again.

This is a Notice of Violation pursuant to Section 25-174. All referenced violations shall be corrected within 4 hours of this notice. We will again re-inspect the premises on March 10, 2015, at which time compliance is required. As this is at least your third violation notice within an 18-month period, we are ordering pursuant to 25-174(a)(5) that you install roof guards on your building at your expense to prevent the falling of snow and ice. Please call me to inform me what steps will be taken to clear any potentially dangerous snow and ice and when installation of roof guards will occur.

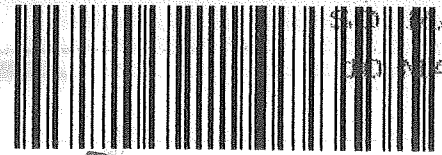

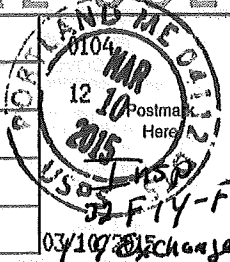
