Assignment and Assumption of Lease

WHEREAS, it is the intention of the parties hereto that Assignor's interest in and obligations under the Lease be assigned to and assumed by Assignee as hereinafter set forth.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereto agree as follows:

- 1. <u>Assignment and Assumption</u>. Assignor hereby sells, transfers, conveys, grants and assigns to Assignee, its successors and assigns, all right, title and interest of Assignor in and to the Lease. Assignee hereby accepts such assignment and assumes and agrees to punctually pay and perform all obligations, liabilities and responsibilities of Assignor under the Lease, from and after the date of this Agreement. Assignor hereby agrees to pay and perform all obligations, liabilities and responsibilities of Assignor under the Lease incurred prior to the date of this Agreement.
- 2. <u>Miscellaneous</u>. This Agreement shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors and assigns. This Agreement shall be governed by the laws of the State of Maine.




