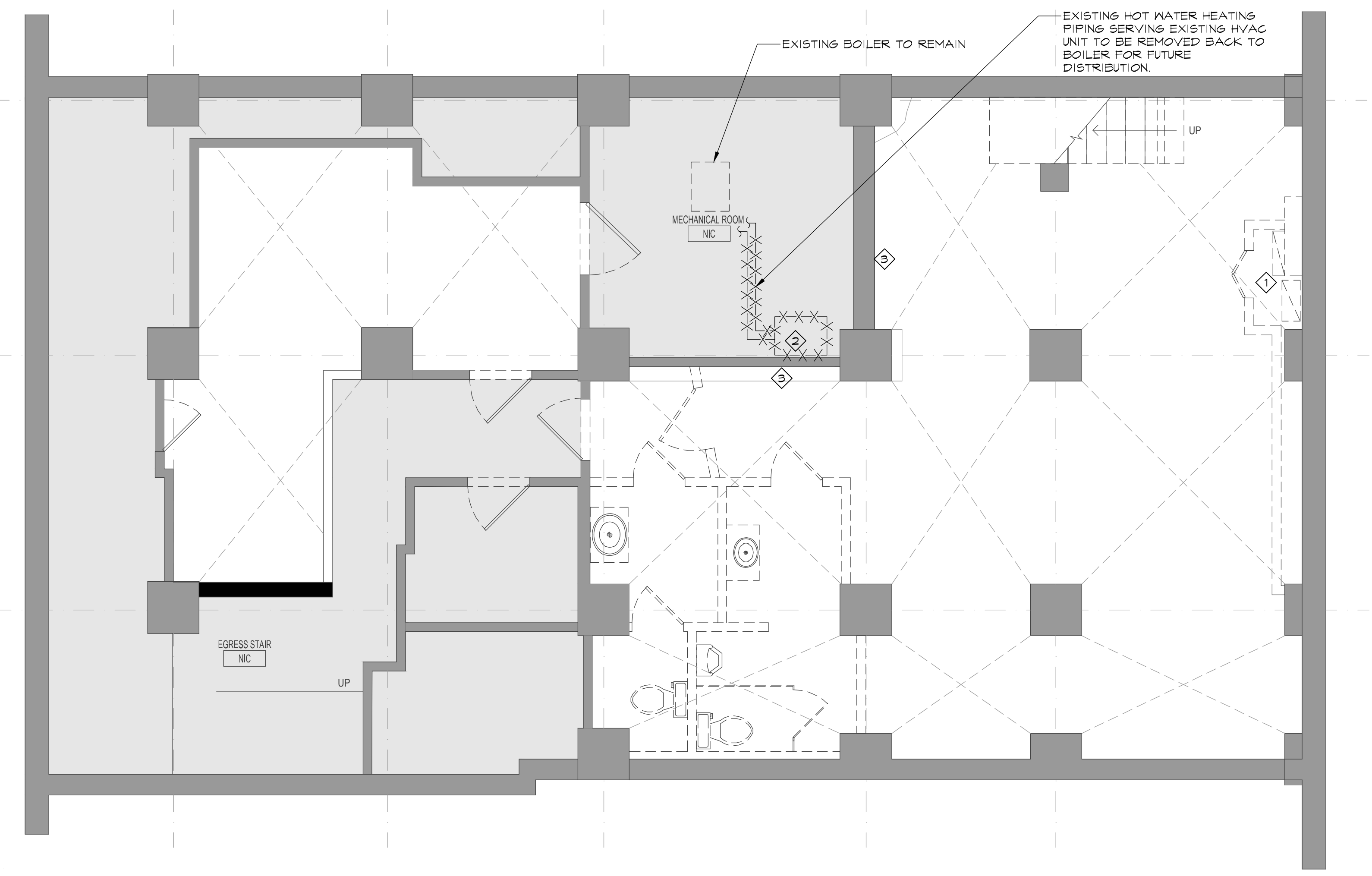

## H. V. A. C. BASEMENT DEMOLITION PLAN

SCALE: 1/4" = 1'-0"

### PLAN NOTES:

- REMOVE EXISTING SUPPLY AIR DUCTWORK WITH ALL ASSOCIATED BRANCHES, DIFFUSERS, COLLARS, STRAPS, AND DAMPERS AS INDICATED ON THE DEMOLITION PLAN.
- ALL EXISTING SUPPLY DIFFUSERS AND RETURN REGISTERS TO REMAIN OR TO BE RELOCATED ARE INDICATED ON THE M-300 SHEET.
- REMOVE ALL MECHANICAL ITEMS NOT BEING REUSED.
- CONTRACTOR SHALL PROTECT ANY EXISTING DIFFUSER/GRILLE, VAV BOX, TEMPERATURE CONTROLS, ETC. TO REMAIN THROUGHOUT CONSTRUCTION.
- PROVIDE TRAVERSE READING AT EACH EXISTING EVAPORATOR UNIT TO REMAIN INDICATING TOTAL CFM AND STATIC PRESSURE. PROVIDE REPORT TO ENGINEER.

### REFERENCE NOTES:

- EXISTING PENTHOUSE LOUVER AND ALL ASSOCIATED DUCTWORK SHALL BE REMOVED. CONTRACTOR SHALL PATCH AND SEAL ALL OPENINGS AND MAINTAIN FIRE RATINGS.
- EXISTING AIR-COOLED SPLIT SYSTEM, ASSOCIATED DUCTWORK TO BE REMOVED.
- EXISTING OPENINGS TO MECHANICAL ROOM SHALL BE REPAIRED. COORDINATE FIRE RATING WITH ARCHITECT.

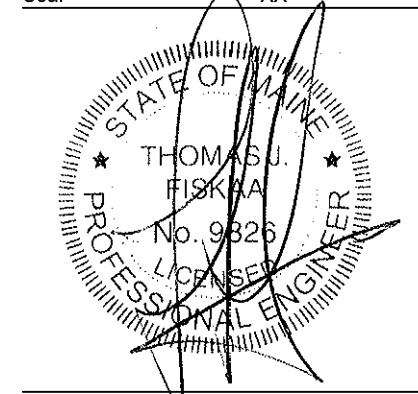
